

ORDINANCE 3089

AN ORDINANCE AMENDING ORDINANCE NO. 3078 ADOPTED ON DECEMBER 21, 2020, ENTITLED "AN ORDINANCE ADOPTING THE BUDGET FOR ALL MUNICIPAL PURPOSES AND USES FOR THE YEAR 2021"

WHEREAS, Ordinance 3078 was adopted on December 21, 2020 that established the annual budget for fiscal year 2021, and

WHEREAS, The 2021 budget was intentionally lean across all funds and departments because of the concerns about the future of the economy at the time of budget development due to the continued impact of COVID-19, and

WHEREAS, One full time position was removed from the 2021 Parks and Recreation budget, and that position has in part been filled with non-represented staff who are no longer able to support those tasks as post Covid programming gets underway in the department, and

WHEREAS, the department is deferring maintenance and falling behind on regular projects, and

WHEREAS, the Parks and Recreation department request the authority to return that position back into the budget to ensure City Parks are maintained at the high level our citizens have come to expect.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Anacortes, Washington, as follows:

Section 1. Ordinance No. 3078 dated December 21, 2020 adopting the Budget for all Municipal purposes and Uses for the fiscal year 2021 is hereby amended to reflect the aforementioned revisions to expenditures and revenues in the following areas:

CONSUMER DISCLOSURE

From time to time, Ingram Micro OBO Cities Digital Inc OBO City of Anacortes (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
