

**ORDINANCE NO. 4011**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ANACORTES,  
AUTHORIZING ACCEPTANCE OF A RESTRICTED DONATION TO THE CITY OF  
ANACORTES**

**Whereas**, the City of Anacortes authorizes acceptance of donations through AMC chapter 3.10,  
and

**Whereas**, the City would like to accept a donation of \$550,000 from Anacortes Skate Park  
Improvement Project to be used in accordance with the donative intent of providing funding to  
design and construct a new skatepark by the City of Anacortes Parks and Recreation department;  
and

**Whereas**, the City would also like to accept a donation of \$100,000 from the Kiwanis Club of  
Anacortes via the Anacortes Parks Foundation for this project; and

**Whereas**, the amount of this restricted donation requires acceptance by City Council.

**Now, therefore, the City Council of the City of Anacortes does ordain as follows:**

Section 1. That these donations totaling \$650,000 by the parties noted above be accepted for  
use on the design, bid and construction of a new skate park on the site of the existing  
Ben Root Skate Park; and


Section 2. This ordinance shall take effect five (5) days from and after its passage, approval and  
publication in the manner required by law.





## **CONSUMER DISCLOSURE**

From time to time, Ingram Micro OBO Cities Digital Inc OBO City of Anacortes (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign, Inc. (DocuSign) electronic signing system. ### **Getting paper copies**

### **Withdrawing your consent**

### **Consequences of changing your mind**
