

**INTERLOCAL AGREEMENT  
FOR CONSTRUCTION OF  
SKATEBOARD PARK**

PARTIES

The Parties to this agreement are:

1. The CITY OF ANACORTES, WASHINGTON, a municipal corporation of the State of Washington (City); and
2. SKAGIT COUNTY, WASHINGTON, a municipal corporation of the State of Washington (County).

RECITALS

WHEREAS, County and City recognize the need for facilities which provide a positive recreational opportunity for citizens, and particularly for youth, and

WHEREAS, County and City recognize that skateboard facilities are a popular and positive recreational activity particularly among youth, and

WHEREAS, County and City recognize that appropriate skateboard facilities are lacking in the City and County,


NOW, THEREFORE, in consideration of the mutual obligations set forth herein, and under the authority of Chapter 39.34 RCW, it is agreed as follows:

AGREEMENT


1. **Purpose:** The purpose of this agreement shall be to provide for the construction of a Skateboard Park as described on the attached Exhibit A.
  - A. City agrees to construct the park described above, and to maintain such park for use by residents throughout the County.
2. **Legal Entities:** No new or separate legal entity shall be created by this agreement.
  - A. This park shall be under the exclusive ownership and control of the City. County shall assume no obligation for maintenance or control and shall not be liable in any way for injuries or damages resulting from the use of the park. City agrees to hold County harmless therefore.
3. **Method of Termination and Disposition of Property:** Upon termination of this agreement, as set forth in Section 5, all property shall remain in the exclusive ownership of the City.
4. **Financing:** City shall be solely responsible for providing the funding to construct this park, except as provided herein. Such funding may come from grant sources, other governmental agencies and/or any available City funds.
  - A. County, in consideration of the construction of the skateboard park by City, agrees to pay to City the sum of TWENTY THOUSAND DOLLARS (\$20,000.00).

5. Duration: This agreement shall remain in effect until the funds provided for in Section 4, A, have been paid by County, and the park described in Section 1 has been constructed by City.
6. This is the entire agreement between the parties, and by signing, each party indicates having read and understood it.


